## Subcommittee on Release of Agriculture-Related GMOs

- Agriculture-related GMOs refer to animals, plants, microorganisms and vaccines used in cultivation, farming, agronomy, husbandry and horticulture or as food.
- The Subcommittee evaluates, advises and makes recommendations on proposed releases of agriculture-related GMOs in Singapore.
- To aid this effort, GMAC published the Singapore Guidelines on the Release of Agriculture-Related GMOs in August 1999.

# Subcommittee on Labelling

- The Codex Alimentarius Commission is an international body jointly established by the Food and Agriculture Organization and the World Health Organization to develop food standards. Singapore is a member of Codex and participates actively in its deliberations including GM related topics.
- The matter of labelling of GM foods is a complex one and so far, there has been no international consensus on the need for mandatory GM labelling. Codex has not recommended any guidelines on mandatory GM labelling and there is also no uniform labelling scheme among countries that have mandated GM labelling.
- The Subcommittee will continue to monitor developments on this issue and make recommendations to the relevant regulatory agencies.

## Subcommittee on Public Awareness

- GM technology has various applications in many fields, such as food production and medicine. It therefore is a subject important to all Singaporeans. However, it may be challenging for the general public to fully understand the concepts and the science involved.
- The Subcommittee thus aims to impart objective, factual and science-based information in a form that members of the public can understand to make informed decisions.

Did you know The GMAC Students Challenge was started in 2008 to raise awareness about GM technology.

# Subcommittee on Research

- Since the launch of the Singapore Biomedical Sciences (BMS) initiative in 2000, the BMS cluster has grown to be one of the key pillars of Singapore's economy.
- To promote the culture of safety when working with GMOs, GMAC published the Singapore Biosafety Guidelines for Research on GMOs to guide researchers.
- The Subcommittee consisting of scientific experts should be consulted on all medium to high risk studies involving GMOs.

• GMAC was established in April 1999 under the purview of the Ministry of Trade and Industry and continues to provide scientifically-sound advice on matters pertaining to GM technology.


# **Our Objective**
